Wycombe Management Conference 2024 Royal Grammar School in partnership with Wycombe Abbey School

I am writing to invite your son to take part in the 33rd annual Wycombe Management Conference in partnership with Wycombe Abbey, taking place on **Wednesday 6th March (12:55 – 18:15) and Thursday 7th March (08:40 - 18:15)**

The conference provides an excellent experiential learning opportunity and is supported by business mentors from a diverse range of companies. It aims to develop the students' commercial awareness, leadership and teamwork, creativity and project management skills. It is also an excellent opportunity for many of our Year 12 to hear from outstanding speakers from industry and commerce and to experience decision-making in situations that could occur in their future working life. The keynote speakers this year are Lord Bilimoria, Founder of Cobra Beer and former chair of the CBI, Catherine Wyman, medical product developer and Peter Higgins, co-founder of Charles Tyrwhitt. I would strongly encourage students studying any combination of A levels to apply.

This year's event will take place in person at Wycombe Abbey. In addition to hearing talks from illustrious speakers, delegates will also participate in a **virtual business simulation**. In a small team of RGS and Wycombe Abbey students, students will be tasked with making decisions to launch and run a new mobile phone shop. The simulation is led by Business Smart International, who work with major corporations and business schools including Barclays, Vodafone, King's College London and Cass Business School. Students will need to make decisions on branding, location, staffing, products, costs, advertising, and deal with a changing market. Throughout the simulation, students will be given advice and feedback by a mentor who has personal experience in the business world, to help them make better business decisions. At the end of the conference, the team that has made the most profit will win a prize.

Within the terms of the School's policy on charging, I am writing to ask for your agreement to your son attending this conference and to ask for a voluntary contribution of £40. This contribution covers the costs of keynote speakers, the virtual business simulation and the support of Business Smart International and all meals and refreshments.
