## Wycombe Management Conference 2021 Royal Grammar School in partnership with Wycombe Abbey School

I am writing to invite your son to take part in the 30<sup>th</sup> annual Wycombe Management Conference, in partnership with Wycombe Abbey taking place on **Wednesday 3<sup>rd</sup> March and Thursday 4<sup>th</sup> March (09:00-16:30)** 

This is an excellent opportunity for many of our Year 12 to hear from outstanding speakers from industry and commerce and to experience decision-making in situations that could occur in their future working life. The speakers confirmed for the Conference so far this year are Lord Bilimoria, Founder of Cobra Beer, Peter Higgins, Former CEO of Charles Tyrwhitt and Jo Hilditch, Managing Director White Heron. The conference is supported by business mentors from a diverse range of companies and aims to develop the students' commercial awareness, leadership, teamwork, creativity and project management skills. I would strongly encourage students studying any combination of A levels to apply.

Due to the current situation, this year's event will be run virtually on Zoom. There will be the opportunity to hear talks from illustrious speakers and to participate in a virtual business simulation. In a small team of RGS and Wycombe Abbey students, students will be tasked with making decisions to launch and run a new coffee shop. The simulation is led by Business Smart International, who work with major corporations and business schools including Barclays, Vodafone, King's College London and Cass Business School. Students will need to make decisions on branding, location, staffing, products, costs, advertising, and deal with a changing market. Throughout the simulation, students will be given feedback to help them make better business decisions. At the end of the conference, the team that has made the most profit will win a prize.

Within the terms of the School's policy on charging, I am writing to ask for your agreement to your son attending this conference and to ask for a voluntary contribution of **£27**. This contribution covers the costs of keynote speakers, the virtual business simulation and the support of Business Smart International. The 99 places for this event (which in previous years sold out in less than 48 hours) will be allocated on a first come first served basis. Please note that where the School is required to make non-refundable payments to any provider, we would not be able to provide a refund should your son withdraw from this conference.
